

## Zhen Ding Technology Holding Limited (4958 TT) April 2022 Monthly Revenue Report

Zhen Ding Technology Holding Limited (Ticker: 4958), a leading global PCB manufacturer, today reported April 2022 revenue of NT\$10.34bn, up 8.29% YoY from NT\$9.55bn for the same period last year. For January through April 2022, cumulative revenue reached NT\$44.26bn, up 20.51% YoY. According to Zhen Ding, due to the global supply chain and logistics disruptions, a portion of downstream customer demand was delayed, which indirectly impacted the company's April revenue. However, compared to the same period last year, both the computers and consumer electronics segment and the IC substrate segment have benefited from the increase in new production capacity, which again drove a record high revenue in both April and the first four months of the year.

According to Zhen Ding, despite facing macro uncertainties, based on current customer demand, the company remains optimistic that its smartphone-related business will maintain stable growth this year. For computers and consumer electronics, with its industry-leading quality and yield, the company expects significant growth in this business as new Mini LED capacity gradually increases. For IC substrate, the new capacity of the new BT fab in Qinhuangdao will come online in the third quarter of this year, which will further boost its IC substrate revenue. Overall, Zhen Ding remains confident to achieve double-digit growth in both revenue and net income in 2022.
