

## **Zhen Ding Technology Holding Limited (4958 TT)**

## **August 2022 Monthly Revenue Report**

Zhen Ding Technology Holding Limited (Ticker: 4958), a leading global PCB manufacturer, today reported August 2022 revenue of NT\$16,539 million, up 13.90% YoY and up 25.36% MoM. For January through August 2022, cumulative revenue reached NT\$98,182 million, up 18.11% YoY. According to Zhen Ding, revenue in August and the first eight months of the year both reached record highs for the same period again. Specifically, August revenue was mainly driven by the preparation of shipments for customers' new product launches. This further increased the company's utilization rate, and the smartphone related revenue not only delivered significant MoM increase but also achieved double digits YoY growth.

According to Zhen Ding, following the mass production of customers' new products, it expects that the revenue of the second half will be significantly higher than that of the first half. In addition, as utilization rates and operating efficiency for all product lines are expected to increase, the company expects full year net income growth in 2022 will be higher than revenue growth. Meanwhile, Zhen Ding also emphasized that, while Shen Zhen recently tightened COVID curbs, the company's operation and shipments have not been impacted. It will maintain flexibility in capacity arrangement to drive stable growth.
