

Zhen Ding Technology Holding Limited (4958 TT)

May 2022 Monthly Revenue Report

Zhen Ding Technology Holding Limited (Ticker: 4958), a leading global PCB manufacturer, today reported May 2022 revenue of NT\$11.56 billion, up 16.33% YoY from NT\$9.93 billion. For January through May 2022, cumulative revenue reached NT\$55.81 billion, up 19.62% YoY. According to Zhen Ding, revenue in both May and the first five months of the year both reached record highs again, driven by the continued momentum in the shipments of computers and consumer electronics products as well as IC substrates. Specifically, all capacities for IC substrates continued running at full utilization.

According to Zhen Ding, while the pandemic has disrupted the global supply chain, the company has been able to maintain a stable pace of growth under its One ZDT strategy with synergies from diversifications. For IC substrates, as previously scheduled, the new capacity of the new BT fab in Qinhuangdao will come online in the third quarter of this year, driving revenue growth. For computers and consumer electronics, with Zhen Ding's industry-leading quality and yield, and as the industry enters a traditionally stronger season in the second half of this year, the company expects significant growth in this business by adding new capacity and gaining market share. Overall, Zhen Ding remains confident to achieve double-digit growth in both revenue and net income in 2022.
