

Zhen Ding Technology Holding Limited

The Company established the "Sustainability Development Committee" at the board level on December 28, 2021, which is composed of the Chairman and two independent directors. The Chairman serves as the convener of the "Sustainability Executive Committee" and is responsible for supervising the composition of the Company's senior team. The Company has four major executive groups: sustainable management, green products, environmental energy conservation and social inclusion. In order to improve the operational efficiency of functional committees and strengthen their powers, the Company's Board of Directors approved to merge the Nominating Committee and the Sustainability Development Committee on December 26, 2024, and to increase the power to review corporate governance. The new name is Corporate Governance, Sustainability and Nominating Committee. The Committee appointed new committee members for the same term as the appointed Board of Directors.
