

Zhen Ding Technology Holding Limited (4958 TT)

June 2024 Monthly Revenue Report

Zhen Ding Technology Holding Limited (Ticker: 4958), a global leading PCB manufacturer, today reported June 2024 revenue of NT\$10,715 million, up 31.84% YoY, reaching the second highest for the same period in the company's history. For the second quarter of 2024, revenue was NT\$32,411 million, up 37.70% YoY, also reaching the second highest for the same period. For the first half of 2024, cumulative revenue reached NT\$64,922 million, up 17.86% YoY.

According to Zhen Ding, its June revenue has continued to deliver a significant YoY increase. All four major product applications, including Mobile Communication, Computers and Consumer Electronics, Automotive/Server/Base Station and IC Substrate, each reached double-digit YoY growth. In particular, revenue for Automotive/Server/Base Station and IC Substrate both marked record highs for a single month, indicating that the company's strategic positioning in these areas has gradually yielded results. Overall, revenue for the second quarter increased by 37.70% YoY during the traditional off-season, exceeding the company's previous expectations.

Zhen Ding expects that, as it enters the traditional peak season in the third quarter, the demand from customers' new products will drive its revenue and utilization rate to further increase. Meanwhile, revenue contribution from IC substrates, servers, and automotive orders will also gradually increase. As a result, the company's performance in the second half of the year will be significantly better than in the first half.
