

Zhen Ding Held the Groundbreaking Ceremony for “Zhen Ding Time Center”, Creating a Joint Hub for PCB and Cultural Industries

Zhen Ding Technology Holding Limited (Ticker: 4958), a global leading PCB manufacturer, today held a groundbreaking ceremony for its Taiwan headquarters, the “Zhen Ding Time Center,” in front of the Taoyuan Qingpu High-Speed Rail Station. According to Zhen Ding’s Chairman Charles Shen, since signing the agreement with the Irrigation Agency on June 5, 2023 to acquire the land for the headquarters, Zhen Ding has actively advanced various preparatory works and successfully obtained the construction approval on January 23, 2025. The “Zhen Ding Time Center” is planned as a premium commercial office building standing 77.5 meters tall, with 13 floors above ground and 3 underground levels, covering an area of approximately 16,000 pings. It is expected to be completed on December 25, 2028. This landmark facility will strengthen connections across Zhen Ding’s manufacturing sites and bring together supply chain partners to create an industrial cluster. Additionally, it will serve as a hub for talent recruitment and development, as well as for enhancing collaboration within the supply chain.

Chairman Shen also stated that, to enhance the work and living quality of employees and partners, the architectural designs of both the “Zhen Ding Time Center” and the Shenzhen headquarters have been entrusted to the internationally renowned architectural firm Gensler. With a professional team of over 6,000 employees and offices in 53 cities worldwide, Gensler enjoys a stellar reputation for seamlessly integrating technology and humanities, innovation and practicality into its designs, endowing the buildings with unique charm and depth. Furthermore, Zhen Ding has always been committed to corporate social responsibility and actively adhered to ESG standards. The “Zhen Ding Time Center” will be the first building in Taiwan to incorporate Coral Life’s globally leading energy-efficient HVAC system, which integrates physics, biology, and data-driven innovations to reduce energy consumption by over 70% while ensuring clean and healthy indoor air. This initiative fully aligns with Zhen Ding's commitment to environmental sustainability. The construction of the building has been entrusted to Li

Jin Engineering, the largest local construction company in Taoyuan. With six decades of history, Li Jin Engineering has constructed numerous renowned corporate buildings and landmarks across Taiwan, earning a distinguished reputation in the field. With their expertise, the "Zhen Ding Times Center" is expected to be delivered on time with exceptional quality, standing as a timeless landmark that endures the test of time.

At the same time, Zhen Ding has partnered with *eslite spectrum* to develop a standalone flagship store spanning nearly 5,000 pings. This space will seamlessly integrate reading, creative design, themed exhibitions, family entertainment, and international dining, forming a joint hub for the PCB and cultural industries. Since signing the agreement with *eslite spectrum* last year, Zhen Ding has incorporated *eslite spectrum*'s requirements into the design and construction process. The grand opening is scheduled to coincide with the completion of the "Zhen Ding Time Center" at the end of 2028.

Chairman Shen emphasized that following the completion of "Avery Time Center" in Shenzhen, "Zhen Ding Time Center" will play a pivotal role in Zhen Ding's global development strategy. It will not only serve as Taiwan's operational headquarters but also become a key hub for collaboration within Taiwan's PCB supply chain, attracting top talent and industry partners. This will further enhance Zhen Ding's competitive edge and reinforce its global leadership in high-end PCBs and IC substrates. Additionally, the collaboration with *eslite spectrum* will support local cultural development and community, marking a new chapter in Zhen Ding's ESG commitment.
