

Participation in external advocacy associations

Zhen Ding actively implements energy-saving and carbon-reduction actions at our global operating locations to respond to Taiwan's "Net-Zero by 2050 Roadmap" and the Paris Agreement. The Company is committed to setting targets in accordance with the Paris Agreement, such as limiting global warming to below 2°C or 1.5°C, achieving net-zero emissions by 2050, and related energy-saving and carbon-reduction measures. In addition to actively promoting energy-saving initiatives among all employees internally, we also participate in external climate-related industry organizations to continuously exchange and stay updated on the latest net-zero emission trends.

In Taiwan, Zhen Ding primarily engages with various international or local industry associations and non-profit organizations. Through diverse methods such as advocacy and policy recommendations, the Company provides relevant suggestions to the government, public associations, or industry associations. These efforts aim to promote industry sustainability, technological innovation, environmental benefits, human rights protection, and responsible supply chain practices. The Corporate Governance, Sustainability and Nominating Committee served as the highest management organization for planning and overseeing sustainable development strategies. It supervised the progress of related work and advocacy for organizational participation, ensuring alignment with the company's sustainability goals and policies, and reported to the board of directors. Given that each public association is established with different objectives and purposes, Zhen Ding's membership in a public association does not imply agreement with all of its positions. We participate in various initiatives or public associations and engage with stakeholders based on the goals set by Zhen Ding to continuously work together to promote relevant policies.

Management System for Climate Lobbying Activities and Trade Associations

We have established a management system for climate-related lobbying activities and participation in industry associations, covering all operational locations of Zhen Ding and its subsidiaries worldwide. This management system ensures that our engagement in climate-related public affairs aligns with the company's sustainability goals, climate change policies, and the requirements of the Paris Agreement. The ESG Executive Committee, under Corporate Governance, Sustainability and Nominating Committee, is responsible for overseeing and coordinating all climate-related activities, ensuring that they are consistent with our corporate values and strategic objectives. The committee reviews and approves participation in industry associations and lobbying efforts, monitors compliance with relevant policies, and reports on the effectiveness of these activities to the Board of Directors.

Trade Associations and Direct Lobbying

Zhen Ding actively participates in industry associations related to climate change, hoping that the operations of these associations will better align with our principles for addressing climate change and achieving net-zero emissions. Regarding participation in these associations, Zhen Ding has established the following management and oversight procedures:

1. We will review the industry associations we participate in to identify those that address climate change and related goals, such as the Paris Agreement, or engage in advocacy and promotion on climate issues, thereby including them in our organizational management focus.
2. We will regularly assess and monitor these entities to ensure their activities align with the goals of the Paris Agreement, such as the 2050 net-zero target and the ongoing promotion of sustainable development.
3. For industry associations that are inconsistent with our climate policies and objectives, we will coordinate and communicate with the associations or their members to align their goals and positions with those of the company. If alignments is not achieved within two years, we will withdraw from the association.
4. We will track the execution progress and report regularly to the Board of Directors on progress and outcomes.

2024 Evaluation Results

Direct Lobbying

Zhen Ding did not conduct any direct lobbying in 2024.

All climate-related trade associations in which Zhen Ding participates are aligned with the Company's climate objectives; no misalignments were identified in 2024.
